**Footnotes**

PRIMARY NOTICE chased the pace to the turn, was fanned four wide while rallying to the stretch, continued to respond in the drive, battled the runnerup to deep stretch then got the best of that one late. VICTORY KID set the pace while racing off the rail to the stretch, dug in determinedly when challenged by the winner but was outkicked late. VICTORY TRAIL broke a step slow and was outrun early, bid three wide to the stretch then finished willingly through the final furlong. MAIDENS JUSTICE had no speed and trailed to the turn, was pushed four wide mid turn then closed steadily in the latter stages. DEFEND LIBERTY tracked the leaders to the turn but was caught out widest and circled five deep to the stretch then closed ground belatedly. BRUNO'S WAGER prompted the pace to the turn, raced three wide to the stretch, was outkicked to mid stretch and weakened. WILLIE THE FOX tracked the leaders to the turn, saved ground and moved up to loom a factor to mid stretch but tired in the final furlong.
