### Footnotes

ARRIVEDERCI CARO was not asked for speed early on and lagged well back, commenced her bid into the second turn, quickly circled rivals five wide to the stretch, collared GOTNACEUPERSLEEVE nearing the furlong pole and drew clear driving. GOTNACEUPERSLEEVE was quickly in front to set all of the pace from the inside to the stretch, could not go with the winner in the stretch but held well for the place. COLLATING LADY settled early three wide, advanced four wide into the stretch and flattened out. QUIET ADVICE raced close up early from the three path, dropped inside for the second turn to loom a factor into the lane but weakened past mid stretch. BLUE MOON HIGH was permitted to lag early, came three wide to the stretch but failed to muster a closing response. DERBY MEMO passed tiring horses. LADY DEPUTY settled early, offered a menacing bid three wide on the second turn but lost her punch. CAMILA CABALETTA saved ground to no avail. CEES JEWEL prompted the pace to the second turn, stopped then was eased in the stretch but walked off. FANNE LU was forwardly placed for a half mile and stopped then was eased in the stretch but walked off.
