Footnotes

WANT THE FACTS sped clear on the first turn then was taken in hand and rated on the backstretch, edged clear again on the second turn, kicked away to mid stretch then held on despite tiring late. PRINCE NOVETTI had no speed and trailed to the half, bid three wide into the second turn, was forced out five wide to the stretch, responded in the drive then was drifting inward through the drive, brushed VEZUVIY in mid stretch then continued inward, bumped VEZUVIY late and bested that one. VEZUVIY was fanned five wide on the first turn, settled to the second turn, raced four wide to the stretch then was brushed by the runnerup in mid stretch and bumped by that one in deep stretch and was outfinished. BUILT FOR THEDERBY was allowed to settle to the half, came three then four wide on the second turn and finished in a mild rally. TAYLOR MOUNTAIN chased the pace to the backstretch then moved up to draw alongside the winner after a half mile, was three wide and outkicked on the second turn and tired in the drive. RETROS LAST FLIGHT was four wide to the backstretch, tracked the pace and got to the rail to save ground on the second turn but came up empty in the lane. OESTE DOS was forced out six wide on the first turn, also tracked the pace to the second turn then failed to rally when asked in the stretch. THROW IT TREY chased the pace from the rail for six furlongs but gave way in the stretch. WORLD OF COLOR chased the pace early, offered his best bid four wide on the second turn but gave out through the lane. EL TEJON showed little. The stewards conducted an inquiry into the stretch run involving PRINCE NOVETTI and VEZUVIY but determined that although there was contact it was not enough to affect the order of finish. It was a majority decision.
