ENSIGN MORANSKI broke alertly then took back just off the leaders, was permitted to move up three wide under her own courage on the turn, took command into the stretch then drew clear under intermittent urging. COASTAL SKIMMING raced unhurried early, came four wide to the stretch and finished steadily without being a serious threat to the winner. JOJO'S JUSTICE was off a step slow then rushed to the lead from the rail, gave up the advantage at the quarter pole and slackened in the lane. ME A TEAZA raced up behind the leaders from the rail into the turn but lacked a closing response. SUPER LIKIT was never a factor. SMOKINBELLE pressed the pace two wide to mid turn and stopped.
