**Footnotes**

AUGMENT took command and opened a clear advantage in the opening stages and set all of the pace from off the rail, was headed by DEACON SPEAKIN' into the stretch but came again and to get the lead nearing mid stretch and won driving. DEACON SPEAKIN' was always well placed, moved up inside AUGMENT into the stretch to take command but but could not sustain his bid and was outfinished in the final furlong. FORM A POSSE lagged early from off the rail, commenced his bid three wide on the second turn and finished steadily. SAND HARBOUR stalked the winner three wide throughout but lacked a closing response. AWESOME JARED was permitted to settle early, raced two wide on both turns and did not rally. STRATE OFF THEBLOC saved ground throughout to no avail.
