MICKEY'S HOUSE contested the pace from the rail to the quarter pole, was edging away into the stretch, had the rider drop his whip at the three sixteenths but continued on under strong hand pressure and held driving. DANCING YODELER tracked the leaders to the turn, raced two wide to the stretch, was outrun to mid stretch then just saved second. ONE MO also was tracking the pace, got fanned out four wide to the stretch then finished evenly and just missed the place. DOUBLE EPISODE chased the pace to the turn then saved ground to no avail. UNDENIABLE FACT was also chasing to the turn, was forced out four deep mid turn then had to circle five wide to the stretch and did not threaten in the drive. RANSOM DEMAND attended the pace outside the winner to the middle of the turn then gave out, was eased in the stretch but walked off.
