Footnotes

NOISE OF THE CROWD broke alertly and dueled the runnerup two wide to the stretch, edged away in upper stretch then drifted inward when clear of LIL BABY ELSA forcing that one to shift out, lugged out under left handed urging late and held. LIL BABY ELSA was pushed early to go up and engage the winner for the lead, dueled from the rail to the quarter pole, was outkicked into the stretch, had to shift out when the winner came in nearing mid stretch then had to check when NOISE OF THE CROWD lugged out late and was outfinished. PEARL LAKE was outsprinted to the turn, bid three then four wide to the stretch and finished willingly in the late stages. CASTINETTE DANCER had no speed, raced three wide to the stretch and was closing ground late. TRIBAL MAGIC tracked the pace from off the rail to the stretch but failed to rally in the drive. FAMILY ORIENTED had speed to the turn, saved ground but gave out through the final furlong. The rider on LIL BABY ELSA lodged an objection against the winner for alleged interference in deep stretch but the stewards ruled that LIL BABY ELSA was not cost a placing so no change was warranted.
