Footnotes

LUCKY FITZ was bumped by SEA CANDY RIDE at the start and outsprinted, lost ground to the leaders to mid turn while going evenly, rallied between rivals to the stretch, eased out in upper stretch then closed with a strong late run to be along in time. RED DIRT chased the pace to the turn, advanced two wide to the stretch, responded to urging and took a short lead in deep stretch then could not hold off the winner. MINISTERS POWER sped clear in the early stages, responded when challenged mid turn, remained a factor to deep stretch then weakened. SEA CANDY RIDE was bumped hard and forced to take up shortly after the break, moved up willingly on the turn while saving ground then finished well in the final furlong. YAH NEVER KNOW had no speed, raced three wide to the stretch then also closed willingly late. STRINGTOWN CAT chased the leader to the turn, advanced into contention while outside of RED DIRT and three wide to the stretch but gave out in the final furlong. RICHARDSONGDANCE had no speed and was not a factor. WIN FOR DIXIE broke inward sharply and bumped hard with SEA CANDY RIDE then was not a factor.
