RENEWED INNOCENCE broke quickly and was clear early, maintained her advantage into the lane then drew off while being kept to her task. FREE TO KNIGHT was unhurried in the early stages, circled rivals four wide on the turn and finished steadily. DRIFTER'S DAUGHTER lacked good early speed, followed FREE TO KNIGHT into the lane from the outside and came on. JEN FIX was void of early speed, saved some ground to the stretch then passed tired horses. WATCH THIS GAL tracked the winner two wide into the lane and had little left. SHANES TANK settled early raced two wide to the stretch and failed to rally. BIEN AMOUR lacked early speed, was two wide on the turn and never reached contention. REALLY A BUBBLE saved ground to no avail. WAGER ON NIKKI pressed the pace three wide and stopped. CON CORAZON was squeezed off at the start, lagged then did not rally while three wide on the turn. JEWELED CASE settled early, raced two wide on the turn and came up empty.
