Footnotes

FASHIONATOR broke alertly and tracked the pace from the outside, challenged for the lead three wide on the turn, took command in the upper stretch and held driving. BEAU DIABLO dueled between horses to mid turn, resisted the winner into the upper stretch but could not match strides and held the place. QUACKIN was void of any speed to the stretch, angled out and finished full of run. BLAST THE CAT ducked in sharply after the start then stalked the leaders from the inside to the stretch but lacked a closing response. MOJAVE MANDATE was bumped and steadied after the start to fall back, saved ground on the turn but could not reach serious contention. DECISIVE FACT was bumped and steadied after the start then settled, moved up briefly two wide on the turn but could not sustain it. CRAZY LORENZO steadied after the start and lagged early, raced four wide on the turn and did not offer a bid. CROCKER'S CORNER flashed some speed from the rail but came up empty on the turn. DEVIL'S SAINT broke slow, raced up from the outside on the backstretch, was fanned five wide on the turn and weakened. RODEOTIME was well placed early but slackened from the three path on the turn. HARLAN'S HALO prompted the pace from the rail and gave out. Following a stewards inquiry, BLAST THE CAT was disqualified for interference after the start and was

placed sixth.
