MARY'S APP had no speed, was roused after a half mile, circled rivals five wide to the stretch then continued to respond in the drive and was along in time. GANNICUS prompted the pace to the half, saved ground on the second turn, rallied to loom a threat to mid stretch then could not stall the winner late. ST PIRRAN was outrun for a half mile, bid two wide on the second turn then finished steadily in the lane. DANGER LURKING set the pace in hand to the half, responded to pressure while off the rail on the second turn, remained a factor to inside the furlong grounds but was weakening late. EXTRA HOT chased the pace to the half, bid three then four wide and rallied to mid stretch but was outfinished in the late stages. GAME OF KINGS took up shortly after the start, trailed to the second turn, raced three wide while rallying on the second turn but could not make an impact in the drive. RACER MOBILE tracked the pace to the half, offered his best bid three wide to the stretch but weakened through the drive. BIG ROCK CANDI checked off heels into the first turn and shifted off the rail, settled mid pack to the second turn then saved ground but lacked a closing response. GRAND GIZMO was allowed to settle early, dropped back to last on the second turn and never threatened. FINE AS FROGS HAIR stumbled badly at the start and lost any chance.
