**Footnotes**

WRATH OF EVAN settled early, moved up into the second turn, offered his bid four wide into the lane, took command at the furlong pole and held driving. POET'S COVE raced unhurried early while off the rail to the backstretch, moved up five wide on the second turn, loomed a bold threat a furlong out but lost his punch. CHATTY CALL was void of speed to the second turn, angled five wide into the lane and finished willingly. BALL YARD settled early from the rail, remained inside on the second turn and slipped back then came again in the lane. MY TOPPER pressed the pace from the outside to the stretch and weakened. CLASS MATE settled early two wide, moved up three wide on the second turn but failed to rally. UNBRIDLED WINNER lagged early from the rail, came four wide to the stretch but lacked a closing response. ONLY TOP MONEY dueled between horses to the head of the lane and gave out. PHANTOM AFFAIR set the pace from the rail to the head of the lane and stopped.
