DEMON WARLOCK broke alertly then took back off the dueling leaders and stalked in hand, advanced three wide into the lane, responded to quickly collar FOXLAIR at the furlong pole but had to be kept to his task to outdueled that rival to the line. FOXLAIR dueled outside INDIO RED into the lane, disposed of that rival but was immediately challenged by the winner, dug in gamely but could not hold. INDIO RED was hustled early to emerge from between horses after the break and engaged FOXLAIR for the lead, dueled into the stretch with that rival then slackened. STATE OFTHE REPORT lacked good early speed, came two wide to the stretch and passed tiring horses. SWEET BIPPY raced unhurried early, was four wide on the turn and did not reach serious contention. OCEAN COVE saved ground to no avail. EBONY EYES stalked the pace from the rail to the turn and gave out. THE LAW OF SEATTLE settled in mid pack early, raced three wide on the turn but failed to respond. IVORY DANSEUR had no speed and was eased in the stretch but walked off.
