CHRISTMAS TIME broke alertly and tracked KONA QUEEN from the rail early, shifted outside that rival nearing the quarter pole to be challenging for command at the head of the lane, responded to steady urging and gradually pulled clear to win driving. KONA QUEEN was quickly in front and dropped to the rail, maintained a clear advantage to the head of the lane then slackened. VIANSO OSSIDIANA bobbled slightly at the start then was permitted to settle, advanced four wide on the turn and finished with some interest. REINE DE CHATEAU raced unhurried early, came four wide to the stretch but lacked the needed response. DEVIL DANCING stalked the pace three wide to the stretch but had no rally. MISS BRIDGET JONES broke a bit slow then recovered to race up and press KONA QUEEN, steadied off that rivals heels nearing the half pole but recovered again and raced up to press the pace from well off the rail, tried to drop back in entering the lane but had little left. BLAZING DEPUTY was never a factor. The rider aboard MISS BRIDGET JONES lodged an objection against KONA QUEEN, and for interference nearing the half mile pole she was disqualified and placed sixth.
