BROUGHT TO JUSTICE was permitted to settle early and raced unhurried to the second turn, advanced in heavy traffic while angling three wide into the lane, rallied steadily to gain command at the furlong pole and won driving. VICKY VALE lagged to the second turn, entered the lane behind heavy traffic and finished steadily through that traffic. SCARLETT'S MARK raced unhurried early while crossing to the rail, remained inside on the second turn, shifted around foes once in the stretch to offered her bid near the sixteenth pole then flattened out. SHESAWALKINGBEAUTY was void of any early speed, offered a menacing bid while being fanned six wide into the lane then lost her punch. STAR'S ASCENT settled early from off the rail, offered a quick bid to the lead five wide on the second turn but could not sustain the rally. ZOZENSUAL was well placed early, offered her best bid four wide and between horses on the second turn and gave way in the lane. RARE ACTION raced unhurried early, was forced five wide into the lane but did not rally. C. C. LA JOIE stalked the pace four wide early then gave way three wide nearing the quarter pole. SUETOSUETOSUE set the pace from off the rail into the stretch and weakened. C T'S SUNSHINE GAL stalked the pace from the rail throughout, challenged at the quarter pole but had little left for the drive.
