HEART'S MUSIC was unhurried to the half, bid two wide on the second turn, swung out into the stretch then closed steadily in the drive to be along in time. MERRY MARINO chased the pace to the second turn, rallied three wide to the stretch then responded in the drive but was outfinished. RIVER RANCH contested the pace while drifting out on the first turn, was two wide to the stretch, dug in to mid stretch but was tiring late. PRINCESS SUSAN M lagged to the second turn, closed the gap two wide to the stretch but flattened in the final furlong. I SWEAR was three wide and settled to the half, got fanned four wide on the second turn but did not threaten in the lane. CYPRUS LADY was floated out on the first turn, pressed the pace to the stretch then gave way. BUTTONS AND BOWS was also settled for a half mile, tried to rally while three deep to the stretch but gave out in the drive.
