### Footnotes

POSITIVE RESPONSE quickly established a clear lead without need of urging, set all of the pace from off the rail, was given a breather into the second turn, but responded when called upon and drew off to win as much the best. GRAND MANEUVER was permitted to settle early from off the rail, moved up gradually into the second turn, loomed a factor from the four path at the quarter pole but proved no match for the winner. KING COLA lagged early and raced just off the rail throughout, rallied to mid stretch but lacked the needed response. RULE HE MUST was forwardly placed from the outset, advanced two wide on the second turn but had little left for the drive. MR. CANDY BAR raced unhurried early while three wide to the backstretch, advanced from just off the rail into the stretch but could not sustain his rally. RUNAWAY WILDCAT was hard held early while racing in mid pack and off the rail then failed to respond while four wide on the second turn. LUCKARACK was fractious in the gate, broke alertly and settled inside, remained on the rail for the second turn but did not respond. EDDIE CODDANA prompted the winner for six furlongs and gave out.
