WILD YANKEE was unhurried to the second turn, advanced inside to the quarter pole then eased out for room, responded to urging once in the stretch and closed steadily to win going away. DANCE CHIEF chased the pace to the half, made a strong run while circling four wide to join the leaders on the second turn, battled to deep stretch then was outfinished by the winner but got the nod for second. UNBROKEN VOW stalked the leaders to the half, raced two wide to the stretch, found room inside in upper stretch, rallied to get to terms to mid stretch then was also outfinished. UNUSUAL SMOKE also stalked the pace, rallied three wide to duel for the lead between rivals on the second turn, battled to deep stretch then was also outfinished. DRY MAN'S GULCH had no speed, was roused into the second turn, got forced six wide to the stretch then finished willingly to the line. BALLET WAY tracked the pace to the half, raced three wide to the stretch but tired in the final furlong.

LONDON EXPRESS was outrun early and settled, came three wide to the stretch but was not a menace. GHERIG got fanned four wide on the first turn, raced mid pack to the second turn then was forced out seven wide into the stretch and failed to respond. ZURI MWANA was hustled, dueled for the lead to the second turn but stopped after six furlongs. SAVOY went wrong on the first turn, pulled up and was vanned off.
