**Footnotes**

GHOST TREE took back at the start and lagged to the second turn, circled rivals four wide into the lane, rallied steadily to gain command in mid stretch and won going away driving. BEAUTIFUL AMERICAN t5racked the leaders from off the rail to the second turn, rallied four wide into the lane, offered her best bid in the upper stretch but could not match strides with the winner. CUVEE BLUSH broke slow and checked then settled from off the rail, moved up three wide on the second turn to take command, led to the furlong pole and weakened. MONICA C C was not asked for speed early while three wide, dropped back to last on the second turn, angled out and finished in a mild rally. MERRY MARINO was permitted to settle early while four wide to the backstretch, came three wide to the stretch but lacked the needed response. BALLET RIBBONS took command from off the rail once on the backstretch and set the pace to the second turn and weakened. KILKENNY CREEK stalked the pace from the rail, remained inside to challenge for the lead at the quarter pole but gave out in the drive. MEAN JOLEENE tracked the leaders three wide to the stretch, dropped inside but lacked a closing response.
