KINGSFORD RED was clear early, dueled when engaged by the winner and was outfinished. APPEALING WATER stalked the pace inside, angled out three wide in the drive, bid late and missed the place. KAROSEL DANCER stalked the pace inside before fading. SUSHI FOR NOAH was through early.
