ROCKEM SOCKEM was unrushed early, rallied inside at the three-eighths pole and closed. MEADOW VESPERS was unrushed early, rallied six wide at the eighth pole and closed fast. DEMAGOGUERY and EQUI POWER raced evenly. KID ATTITUDE and LITE UP passed tiring rivals. ABOVE THE WIND stalked the pace for half mile before giving way. DORTHYS CHAMP set the pace to the far turn before giving way. SOPA stalked the pace to the far turn before giving way.
