**Footnotes**

MERIT MAN took early lead by a slight margin in the opening quarter and was challenged by rivals shortly after, vied for lead along the inside in backstretch, continued to match strides with ROCKYSHOMERUN in the far turn, shook free by a slight margin at top of the lane, challenged by CITY OF WESTON midstretch, dug in gamely and held clear late. CITY OF WESTON allowed to settle in near inside behind early pacesetters, began to advance position two wide in turn, continued three wide bid in stretch and continued steady bid into drive. LITTLE DISTORTED reserved in early stages racing in back of the pack, saved ground along inside in backstretch, made a two wide bid nearing far turn, steadily gained position, continued inside in upper stretch, angled out two to three wide in late drive and slightly gained position. ROCKYSHOMERUN edged up between rivals and vied for early lead, continued to match strides with MERIT MAN at top of the lane and could not keep up the pace in late drive. CAT FIVE HURRICANE pressed early pace in opening quarter, advanced between rivals and vied for lead in backstretch and began to weaken nearing far turn. BRAVE DAVE vied three deep for early lead and began to weaken nearing half mile.
