**Footnotes**

IMPLIED allowed to settle in behind front group of leaders, asked to pick up the pace heading into far turn, swung out four wide at top of the lane, edged up along outside of leaders midstretch, took command and drew clear. BAY ROAD reserved in early stages racing near the back of the pack, asked for response nearing far turn, raced three wide into lane and continued to gain ground between rivals in middle of track in late stretch. UNCAGED HEART took command by slight margin in early stages, continued to lead along inside heading into turn, challenged in turn, vied for lead, took command again by slight margin in uppers stretch but could not keep up pace in late drive. SUMMON THE RAIN stalked along inside in backstretch, steadily gained position along rail heading into far turn, continued to dig in late stretch and lacked final kick in drive. TIME ON MY HANDS drifted out at start, rushed up to track top two leaders in opening quarter, continued to stalk in backstretch, began to advance position three wide in turn, raced within contention midstretch and weakened in late drive. COLORME KITTEN raced up close to leader in opening quarter, continued to press pace along backstretch, continued within contention in

uppers stretch and came up empty in late drive. PEPPERMINT CANDY unhurried in early stages, continued evenly near middle of the pack in upper stretch and finished three to four wide in late drive. FOXIE AFLEET saved ground along inside in backstretch and lacked late needed response in drive. SWEETER TURN settled in early stages, began to advance along outside nearing far turn, raced five wide at top of the lave and had nothing left in late drive. FORMAL RUCKUS traced two to three off inside in stretch and lacked response. KINSALE KELLY raced near the back of the pack in backstretch, continued in middle of track in stretch and failed to make a bid. MONEY ROUND forced slightly outward at start, raced in back of rivals in backstretch and never menaced.
