MONUMENT HILL unhurried after being bothered at the start, moved into contention on the far turn, swung out for the stretch run, rallied to catch ACADEMY ROAD at the sixteenth pole, then drew away. AUSTONS SURE CURE stalked the pace three wide, angled out for the stretch run and closed to be up for the place while unable to match strides with the winner. GULF RUCKUS reserved off the pace, split rivals and rallied to just miss the place. ACADEMY RUN set the pace along the rail, increased his advantage in midstretch, then weakened in the final sixteenth. DUG IN allowed to settle, raced four wide around the far turn and had no late response. PAVORATTI'S SOUL chased the pace to inside the eighth pole, then gave way. JUSTY stalked the pace along the inside into the stretch and tired. LE ROYALE broke to the outside, stalked the pace to nearing the stretch, then faltered. AUTHORITY RULES failed to menace. DUELING ALEX rated off the pace, steadied in behind rivals entering the far turn and dropped back. HOOPOE off slowly, was outrun.
