Footnotes

RAPID RUNNER unhurried early, angled out in the stretch bumping DIXIE SLAM soundly, then rallied to be up late. CLEAN SHOT reserved racing off the rail, steadied when the hole between ABDEL'S GHOST and CONFLICTING REPORT appeared to be closing, recovered and split those rivals while rallying to be up for the place. DIXIE SLAM outrun after stumbling at the start, swung wide for the stretch run, then was bumped hard by RAPID RUNNER and rallied to just miss the place. BE WELCOME rated off the pace, raced along the rail and rallied while being outfinished by the top ones. BOMBAST stumbled at the start, chased the pace three wide, moved to take over in the stretch, then gave way late. ABDEL'S GHOST vied for the lead along the inside into the stretch and tired. LIVIN LARGE raced five wide and failed to menace. CONFLICTING REPORT vied for the lead outside ABDEL'S GHOST into the stretch, then faltered. IN RHYTHM was not a factor. TRIPP O STEEL chased the pace four wide to midway of the turn and faded. FOLLOWING A STEWARDS INQUIRY AND A CLAIM OF FOUL BY THE RIDER OF DIXIE SLAM, RAPID RUNNER WAS DISQUALIFIED AND PLACED THIRD FOR INTERFERENCE TO THAT RIVAL IN THE STRETCH.
