LAWYER JIM quickly took the lead in opening quarter, continued to set the pace along inside by slight margin over FORT MORGAN in the backstretch, began to vie for the lead along inside of FORT MORGAN, continued to match strides into deep stretch, would not give up, dug in and prevailed at the wire. FORT MORGAN raced up close tracking LAWYER JIM in the backstretch, made a bid for leader in the turn, vied along outside of rival into the stretch and just missed win in final strides. SONNYANDPALLY tracked front runners racing along inside of SON OF A TRAMP, asked to pick up the pace heading into

far turn, raced three wide at the top of the lane and continued a steady bid to the wire. COLORADO DAYDREAM stalked along inside in the backstretch, continued near the rail in the turn and finished evenly in the late drive. BALLERINO reserved in early stages racing in second flight of horses, steadily gained ground along outside nearing far turn, raced three wide at the top of the lane and slightly gain position late. SON OF A TRAMP tracked leaders racing two off the inside in the backstretch, asked to pick it up nearing the far turn and lacked late response. MASTER OF MARKETS raced three wide into the lane and failed to be a threat late. SHORTYS FASHION stalked front runners three wide in the backstretch, raced three wide at the top of the lane and lacked response late. MAR BRAVO reserved in early stages, drifted out seven wide in the turn and failed to rally in the stretch. TOUCHNLUCK reserved along the inside in the backstretch and lacked response throughout.
