**Footnotes**

TAKEMDOWN allowed to settle, split rivals in the stretch and rallied to be just up at the wire. PISTOL RULES outrun after being checked at the start, advanced along the rail around the far turn, moved to gain a slim advantage soon after entering the stretch, then just failed to last. FINAL ENDING set the pace off the rail into the stretch, responded when PISTOL RULES moved to the fore and held on well for the show. ABDEL'S GHOST stalked the pace along the inside, eased out leaving the far turn but didn't do enough late. CLOSING COSTS unhurried early, rallied along the inside to loom a threat in the stretch but couldn't sustain his bid. ON THE SPOT outrun early, raced five wide around the far turn and passed tired rivals. LOUDERTHANTHUNDER rated off the pace, advanced four wide around the far turn to reach contention, then tired. SCOTTKEITH'SKITTEN well placed, was taken up on the far turn when

he appeared to clip heels at the quarter pole and failed to recover. AMARILLO SKY reserved off the pace, advanced three wide around the far turn to reach the attending position, then faltered. FIORE DICAMPO was through after six furlongs and steadied to avoid SCOTTKEITH'SKITTEN on the far turn. ILLEGAL WAY prompted the pace outside FINAL ENDING, then was steadied from tight quarters at the quarter pole and faded.
