Footnotes

CALL MY LAWYER rated off the pace after bumping with SINNER'S GOLD at the start, raced four wide around the turn, rallied to catch OH SO SHERRI at the eighth pole, then was fully extended to hold SHEBOP safe. The latter, unhurried after being steadied soon after the start, swung out for the stretch run and closed well for the place. OH SO SHERRI chased the pace three wide, moved to take over leaving the turn, then gave way in the drive. SINNER'S GOLD reserved off the pace after bumping with CALL MY LAWYER at the start, tired. MISS POSSE tracked the pace three wide around the turn and faltered. PERFECT'S LIL SIS showed speed off the rail to the quarter pole, then faded. COWETA saved ground and was done early.
