Footnotes

HIGH FLY stalked the pace three wide, moved to take over at the top of the stretch and drew off while being ridden out. DRUM MAJOR checked inside HIGH FLY soon after the start, advanced four wide around the turn and closed to gain the place while no match for the winner. MAGNA GRADUATE chased the pace off the rail, moved to take over on the turn, then gave way in the drive. GINGER'S FELLA outrun early, angled wide in the stretch and improved his position to just miss the show. D'COURT'S SPEED unhurried early, passed tired rivals in the drive. REY DE CAFE raced in striking position into the stretch and gave way. CHEROKEE CHASE angled in early intimidating HIGH FLY a bit, chased the leaders three wide into the turn, then tired. HAL'S IMAGE bumped with MAGOO'S MAGIC at the start and was not a factor. MAGOO'S MAGIC bumped with HAL'S IMAGE at the start, showed speed well out in the track, angled to the inside entering the turn, then had nothing left after losing the lead. DEPUTY INDY well placed racing along the rail, faltered leaving the turn. VINOTECH raced four wide and was done early. WAHRAN saved ground and faded. The rider of DRUM MAJOR lodged an objection against the rider of HIGH FLY for alleged interference soon after the start. The claim of foul was not allowed.
