**Footnotes**

BADGE OF SILVER stalked the pace, rallied to take over from COMMENTATOR at the quarter pole and opened a clear lead, then was all out to last over DYNEVER. The latter, unhurried while saving ground, angled to the outside for the stretch run and rallied to just miss. CONTANTE (ARG) reserved racing along the inside, swung out on the far turn, rallied to reach the attending position in the stretch but couldn't gain on the winner late. ADDED EDGE tracked the pace, made a run three wide around the far turn to loom a threat in the stretch, then gave way. COLLATERAL DAMAGE outrun early, passed tired rivals in the drive. PURGE reserved early, saved ground while advancing into contention around the far turn, then tired. COMMENTATOR outran SMOOTH LOVER around the first turn to gain the lead, made the pace along the inside to the quarter pole, then had nothing left for the drive. ALLEGED RULER was not a factor. THE JUDGE SEZ WHO rated off the pace, raced three wide on the far turn and faltered. COUNTRY JUDGE allowed to settle, raced four wide on the far turn and faded. WAKE AT NOON was outrun. SMOOTH LOVER showed brief speed and stopped.
