Footnotes

BROAD RIVER set the pace along the rail into the stretch, then was fully extended to prevail. BROOKLYN BOY allowed to settle, swung out for the stretch run and rallied for the place. OFFICER'SGENTLEMAN tracked the pace along the inside, eased out in the stretch, then lugged in at the sixteenth pole impeding ELDOKTORI and weakened. ELDOKTORI rated off the pace, advanced along the rail to reach contention in the stretch, then was checked from inside OFFICER'SGENTLEMAN at the sixteenth pole and failed to recover. WOOD BE ME stalked the pace three wide into the far turn, then gave way.

RUBIDIUM chased the winner into the stretch and tired. WARDYAN failed to menace after being steadied at the start. MAMBO MASTER reserved racing along the rail, steadied on the far turn and never threatened. NEVERI was not a factor. TORRIDORO off slowly, stalked the pace, raced three wide around the far turn and faltered. WISE ESCAPE raced three wide and faded. DANCING CALLING was done early. Following a stewards inquiry, OFFICER'SGENTLEMAN was disqualified and placed fourth for interference to ELDOKTORI at the sixteenth pole.
