R HOLIDAY MOOD set the pace under pressure off the rail, responded when headed by ALL DUE RESPECT in the stretch, came back on to regain the lead, then just lasted to finish on even terms with DELIGHTFUL MARY. The latter, stalked the pace, angled outside the leaders for the stretch run, then rallied to be just up to dead heat with R HOLIDAY MOOD. ALL DUE RESPECT pressed the pace three wide, moved to gain a slim lead in the stretch, then weakened late. SWEET REPENT stalked the pace four wide, dropped back around the far turn, then finished willingly. GORGEOUS MELODY stalked the pace along the inside into the stretch and tired. TOURMALINE rated off the pace, faltered on the far turn. SUCCESSFUL SONG raced with the pace three wide into the far turn, then faded.
