STEPHENTOWN was under stout restraint while tracking the leaders into the stretch, split rivals to take over at the eighth pole and drew away under a hand ride. SLEDGE stalked the pace three wide into the stretch, then was no match for the winner while closing to be up for the place. COURT NOTES unhurried early, swung out for the stretch run and closed to just miss the place. GOVERNOR HICKEL prompted the pace outside LAST INTENTION, moved to gain a brief lead nearing the eighth pole, then weakened. EQUALITY raced in striking position into the stretch and tired. LAST INTENTION made the pace along the rail into the stretch and faltered. COAX ME CODY trailed.
