MATTY'S TRAIL vied for lead in opening quarter, took command and continued to set pace along inside in the backstretch, remained leader at the top of the lane and continued clear. GHOSTWALKING stalked front runners along inside in the backstretch, continued settled along rail in the turn, asked to pick it up at the top of the lane, continued along rail and held place in final strides. SKY VENTURE tracked the top two leaders in the backstretch, raced three deep heading into turn, set down in upper stretch and lacked final kick in late drive. IMPERIAL CZAR bobbled at start, settled in near the back of rivals, raced five wide in the turn, slightly improved position but lacked final kick to make serious threat. COOSADA tracked the pace two off the inside in the backstretch, continued near the front runners heading into far turn but had nothing left for the drive. MR. ESPRESSO reserved in opening stages racing in back of the pack and lacked late needed response in the stretch. JAKESAM raced up close for lead in opening quarter, slightly settled back and had nothing left nearing far turn.
