Footnotes

TIZ IN COURT allowed to settle off the early speed in opening stages, saved ground along the rail, asked to pick up pace nearing the turn, angled out slightly at the top of the stretch, made a bid between rivals midstretch and rushed up late to prevail. THE CHILL ZONE rushed up to take lead by a slight margin, felt pressure from on coming rivals heading into far turn, dug in and continued to hold lead but could not hold off late charging TIZ IN COURT in late strides. ARI'S PRIDE allowed to settle in early stages, continued to save ground along inside, swung out three then five wide in the turn and gained ground in late drive. MEMPHISLIVESINME reserved in early stages, made a bid between rivals midstretch and steadily gained position to the wire. DON'T PUT IT BACK pressed the pace in early stages, edged up to the lead heading into far turn, raced four wide at the top of the lane and had nothing left in drive. GARY D raced just off the pacesetters, made a bid between rivals in the turn, continued within contention at the top of the lane and could not keep up pace in the drive. D' PEPJO stalked the early front runners, began to advance position heading for home, was carried out five wide in the turn and had nothing left in the late stretch. CROCKEFELLER raced evenly near the back of rivals and failed to be a threat. SAGAMORE raced in the back of the pack throughout and failed to make a bid.
