ORCHARD PARK unhurried early, rallied four wide on the far turn, moved to catch BREAKFAST IN MAUI at the eighth pole and drew clear. BREAKFAST IN MAUI outrun early, made a quick move racing down the backstretch to take over three wide on the far turn, then was no match for the winner in the final eighth while proving second best. NOTABLE EDITOR rated off the pace, advanced between horses and outfinished the others for the show. BERNIE B steadied at the start and again on the backstretch, advanced to reach contention in the stretch but had no late response. RICKY N CHIP raced four wide on the far turn and failed to threaten. AVID DAVID steadied when caught in tight racing into the first turn, then was through after a half mile. DR. CLAYTON steadied when caught in tight early and was not a factor. UNBRIDLED AFFAIR showed early foot along the rail and faltered. LORD HARMONY vied for the lead along the inside to the far turn and faded. SUPER STINKER vied for the lead to midway of the far turn and stopped.
