**Footnotes**

VALDERO set the pace along the inside into the stretch and was fully extended to last over HYRULE. The latter, forced the pace along the rail, was steadied when caught in too close to the rail inside VALDERO entering the turn, then steadied again to avoid running up on that rival midway of the turn, eased out and was gaining slowly at the finish. DREAM MAESTRO chased the pace three wide into the stretch and finished willingly. FLYING VEE chased the pace to nearing the stretch, then gave way. WHITE SPOT reserved racing along the rail, was checked from tight quarters entering the turn and failed to recover. MOTION PLAY raced four wide and tired. HARBOR RIDGE showed some early foot and faltered. REXSON'S HALO was no factor after hesitating at the start. TOKORIKI showed little after breaking poorly. DESTINY'S IMAGE raced in striking position into the turn, then faded. A BEE C was outrun. WARDYAN was through after a half mile. The rider of HYRULE lodged an objection against the rider of VALDERO for alleged interference entering the turn. The claim of foul was not allowed.
