GANGSTERONTERUN rushed up to reach contention after breaking poorly, eased three wide on the turn, rallied to take over in early stretch, then drew clear while being ridden out. BOSSMAN BLUE'S tracked the pace, advanced to loom a threat in the stretch but was no match for the winner while gaining the place. CANDI'S HALO pressed the pace outside TRIPLE A. RATING, took over from that rival on the turn, made the pace into the stretch and gave way. SUBTITLES allowed to settle, passed tired rivals in the drive. FORWARD OBSERVER chased the pace four wide into the stretch and tired. MIDNIGHT THUNDER was not a factor. TRIPLE A. RATING showed speed along the rail to midway of the turn, then faltered. M J'S ENCHANTEUR was outrun. ZIPATRON stumbled at the start, chased the pace three wide around the turn and faded.
