**Footnotes**

STORM CLOUDS AHEAD vied for lead in opening quarter, took command by slight margin, began to feel slight pressure from BURNING MANDATE heading into turn, asked to pick up pace at top of the lane, kicked back in under left handed urging and remained clear to wire. BURNING MANDATE tracked the pacesetter in early stages, made a bid for STORM CLOUDS AHEAD going into far turn, began to inch up closer to rival in upper stretch, could not get by and settled for second best. COVER PRICE broke sharp and was allowed to settle back, continued reserved in backstretch, began to advance position heading for home, raced three to four wide into the stretch and steadily gained ground. LORD CHELSIE raced up close tracking the top two front runners, asked to pick up pace heading into far turn, raced five wide into the lane and lacked late kick in drive. BARBARO'S REVENGE reserved in early stages, continued in back of the pack heading for home, raced wide in far turn and slightly improved position along outside in the stretch. Bled racing, was pulled up and walked off. JORDAN'S IMAGE chased the pace along rail in early stages, continued near inside in the turn and failed to kick in the stretch. LONGER TERMS DOUG chased the early pace between rivals in opening stages, slightly weakened position at top of the lane and lacked response in drive. SAPPHIRE COUNTY chased the pace two off inside in opening stages and steadily weakened position after a half mile.
