Footnotes

SWEET AND VICIOUS vied for the lead outside HOT LADY throughout and was fully extended to prevail. HOT LADY vied for the lead along the inside into the stretch and continued on gamely while just being edged to the wire. ADELA'S SONG tracked the pace, eased outside the leaders for the stretch run and closed with a mild response. SASSY Q chased the pace along the inside, eased out in the stretch and was gaining slowly at the finish. HIGHLAND SARA reserved after breaking a step slowly, steadied in behind rivals on the backstretch, angled wide in the stretch, then closed well late. CURSING CATHY rated off the pace after breaking poorly, advanced three wide around the turn to reach contention but didn't do enough late. CHARMING THUNDER was done early.
