DEPUTY'S HONOR chased the pace three wide, rallied to take over at the quarter pole and drew off under urging. SMOOTH VALENTINE unhurried early, closed to gain the place while no match for the winner. LIZARD reserved early, passed tired rivals to be up for the show. QUILLIGAN chased the pace, moved to gain a brief lead on the turn, then tired. LUCRATIVE DEAL rated in striking position off the pace, faltered leaving the turn. SERAPI CAT outrun early, checked to avoid running up on rivals in early stretch and was never a threat. BOB BULL chased the pace to nearing the stretch, then faded. LEWICKI showed speed along the rail into the turn, then had nothing left.
