Footnotes

FROST GIANT chased the pace, rallied to take over at the eighth pole, then drifted out late under left-handed pressure bothering PARADING and prevailed. PARADING rated off the pace, rallied four wide around the far turn, was steadied when forced out by FROST GIANT late and couldn't get to that rival. CODEWORD (IRE) reserved off the pace, advanced to reach contention in the stretch, then weakened. TIVERTON chased the pace after being steadied in behind WORLD WAR on the first turn, moved to take over on the far turn, made the pace to nearing the eighth pole, then gave way. SEDGEFIELD tracked the pace into the far turn, then tired. HIGHEST DEGREE raced three wide and lacked a late response. WORLD WAR set the pace along the rail into the far turn, then faltered. CHARIMOUNT was outrun. DAVID K was never a factor. Following a stewards inquiry, FROST GIANT was disqualified and placed second for interference to PARADING late.
