EVANDERFIELD chased the pace off the rail, rallied to reach even terms for command with BLACK TOP ROAD at the sixteenth pole, then brushed with that rival and prevailed. BLACK TOP ROAD chased the pace three wide, rallied with EVANDERFIELD to reach even terms for command at the sixteenth pole, then brushed with that rival and was edged to the wire. PHIL'S FIRST outrun early, was rallying into contention when he drifted out inside the eighth pole and closed to be up for the show. PETER BOY showed speed along the inside, increased his advantage racing into the turn, continued to make the pace to nearing the sixteenth pole, then gave way. B L'S BIG FISH reserved early, advanced off the rail around the turn to reach contention, then steadied in behind PHIL'S FIRST inside the eighth pole and flattened out. LIZARD'S REPENT chased the pace three wide into the stretch but had no response when asked. WIRELESS MACHO raced four wide and failed to menace. NO INFLUENCE was not a factor. JOHARLINGTON was outrun while racing five wide. JUNIOR V. chased the pace along the rail into the turn, then tired. ROOM MATE raced five wide and faltered. ONE LUCKY PUNCH showed early foot and faded. The rider of BLACK TOP ROAD lodged an objection against the rider of EVANDERFIELD for alleged interference in deep stretch and the rider of B

L'S BIG FISH lodged an objection against the rider of PHIL'S FIRST for alleged interference inside the eighth pole Both claims of foul were not allowed.
