FASTEST MAGICIAN unhurried early, swung out for the stretch run and rallied under pressure to be up late. VERSAILLES ROAD stalked the pace three wide, rallied to gain the lead at the top of the stretch but couldn't resist the winner late. WALKER'S LANDING outrun after breaking slow and stumbling, swung out for the stretch run and closed well for the show. RELAMPAGO rated off the pace, made a run four wide to join the leaders racing into the stretch, then weakened. EAST OF DANZIG reserved off the pace, was racing three wide when steadied in traffic on the far turn, then didn't do enough late. CARNIVAL RIDE allowed to settle, saved ground and failed to menace. POWHATAN COUNTY chased the pace, moved to gain a slim lead on the far turn, then gave way in the drive. KEEP ME INFORMED tired from good position. SHALANGAR (IRE) taken in hand, advanced along the inside around the far turn to reach contention, then faltered. ROCK ALEX set the pace along the rail to midway of the far turn and faded. DECAF AGAIN was outrun.
