**Footnotes**

TIGER WILLIE tracked the pace along the inside, angled out leaving the far turn, was floated out a bit by RICHIE RULES entering the stretch, rallied to catch that rival just inside the eighth pole and edged away. MASTER SERGEANT reserved off the pace, swung out for the stretch run and closed to be up for the place while unable to get to the winner. EXPOSED IMAGE allowed to settle, raced three wide around the far turn, angled out for room in the stretch and closed well to be up for the show. SKYPO tracked the pace, advanced three wide around the far turn to loom a threat in midstretch but didn't do enough late. RICHIE RULES set the pace along the inside, drifted out entering the stretch, made the pace to the eighth pole, then gave way. MR POSTMAN stalked the pace three wide into the stretch but had no response when asked. PERFECT SON reserved in striking position off the pace, moved up into the stretch

but couldn't gain late. LION THUNDER saved ground and failed to menace. WALK THE TIGER chased the pace to nearing the stretch, then tired. KIJO well placed while saving ground, faltered in the drive. MANDATE TO RUN was outrun. JERSEYS BREW showed little.
