ALAUURA MICHELE angled to the inside early tracking just off the first flight while pulling a bit, shifted out four wide deep making some contact with LONG FACE racing into upper stretch, continued to exchange some contact while continuing with a grudging effort between foes to challenge for command and narrowly prevailed in time under firm handling. DENE COURT was urged to secure the lead while angling to the inside, dictated the pace on a narrow margin to the far turn, resisted several challenges racing into upper stretch and just failed to contain the winner. LONG FACE, reserved between foes well off the second flight in early stages, gained some position three deep nearing upper stretch, was carried out by the winner racing into upper stretch while exchanging contact with the that foe and continued with interest to dispute the issue to the end while being just outkicked. PEGGY JOYCE, urged to gain a forward placing while angling inwards, was prompted to press between foes on the far turn to upper stretch but, weakened late. ROYAL FURY tracked off the first flight in the opening stages, moved to challenge three deep racing through the far turn but flattened out in the lane. TRIPLE CHARM (GB) broke slowly, was collected to track outside foes in the second flight to the far turn but lacked the needed final kick. GAMAY NOIR settled between foes in early stages but never gained contention. MOLLY MORGAN tracked off the second flight along the rail in the opening half but offered no closing bid. VIA VILLAGGIO lunged at the start, was held up outside foes in early stages and never subsequently menaced.
