Footnotes

WISE NOTE bumped with BALREVERE at the start, was chasing the pace when she bumped with SARAH and steadied entering the turn, angled out three wide and rallied outside CREME DE LA CAT to take over at the eighth pole, then was fully extended to prevail. CREME DE LA CAT chased the pace along the inside, eased out and rallied to gain the advantage at the top of the stretch, made the pace to nearing the eighth pole, then couldn't resist the winner while holding the place. DANCING FOR MONEY reserved after being pinched back at the start, saved ground around the turn and closed to be up for the show. FIRST ACE rated off the pace, finished willingly in the drive to just miss the show. GOLDEN FLUTE unhurried early, raced four wide around the turn and passed tired rivals. ROSY ROADS OF GOLD raced three wide and failed to menace. LEIA was never a threat after being outrun early. SOLICITRESS away alertly, showed speed while angling over to the inside, made the pace to the top of the stretch, then tired. SARAH chased the pace, bumped with WISE NOTE and steadied entering the turn, then faltered. BALREVERE was no factor after bumping with WISE NOTE and bobbing at the start. MUY PRECIOSA bumped with LAPONY at the start and was done early. LAPONY bumped with MUY PRECIOSA at the start, chased the pace to nearing the stretch, then faded. The rider of CREME DE LA CAT lodged an objection against the rider of WISE NOTE for alleged interference in the stretch. The claim of foul was not allowed.
