**Footnotes**

GO ANNIKA set the pace off the rail into the stretch, then edged away under urging. LA LUNA DE ORO chased the winner three wide into the stretch, then couldn't stay with that rival while clearly second best. MOOREBELLA tracked the pace four wide into the stretch, then couldn't keep pace with the top ones while holding the show. VANTAGE STAR reserved early, saved ground and passed tired rivals. CHANTILLY LIGHT raced in striking position into the stretch and tired. COCOA CREAM rated off the pace, raced five wide on the far turn and faltered. JOJO MARIE up close early, raced four wide on the far turn and gave way. MY KIND OF GAL raced five wide on the far turn and was outrun. RIVER RAFT broke slowly, then was saving ground when checked on the far turn and failed to be a factor. FREE STRIKE showed little. STORMIN PAT chased the pace along the inside into the stretch, faded and was eased late. FROLIC AWAY showed nothing and was eased in the stretch run.
