Footnotes

SEMINOLE LASS tracked the pace, angled outside the leaders leaving the turn, rallied to gain the lead inside the eighth pole, then edged away. REV IT UP RHONDA rated off the pace, rallied through the stretch to gain the place while unable to get to the winner. PRINCESS TOWN chased the pace, moved up to gain a slim lead outside RIVER FANCY on the far turn, vied with that rival to inside the eighth pole and was outfinished. ROMIN ROBIN steadied in the early going and again on the first turn, advanced to loom a threat in the stretch, then gave way. RIVER FANCY moved up on the backstretch to vie for the lead outside GREEDY DEBBY, responded when challenged by PRINCESS TOWN on the far turn, continued to contest the pace to past the eighth pole, then weakened. BOB'S JAWBREAKER failed to menace. GREEDY DEBBY set the pace along the rail to the far turn, then faltered. KIMS WONDER off slowly, was outrun. SPEED NOTE was not a factor.
