Footnotes

NINEINTHENINE reserved off the pace, rallied three wide around the far turn to reach the leaders while still in hand, moved to gain the advantage approaching the eighth pole, then drew clear. WHIRLING THUNDER stalked the pace into the stretch and closed to be up for the place while being outfinished by the winner. BLACK SCORPION allowed to settle, raced three wide around the far turn and rallied to just miss the place. ELDAAFER stalked the pace along the rail, was steadied when caught in behind the leaders nearing the eighth pole and failed to recover. STEPASIDE rated off the pace, steadied from tight quarters soon after entering the far turn, angled out and closed with a mild response. CINNAMON ROAD chased the pace, moved up to engage BROADWAY ACTOR on the far turn, vied with that rival to the eighth pole, then gave way. BROADWAY ACTOR set the pace along the rail, responded when challenged by CINNAMON ROAD on the far turn, then tired in the final eighth. LIVINGSTON STREET pinched back at the start, raced in contention four wide around the far turn and faltered. JAMALUDIN saved ground to no avail. PEACEFUL RUSSIAN was not a factor. BALLYMOY off slowly, was outrun. LUNAR FLEET tracked the pace, then was steadied in traffic on the far turn and faded.
